¹ The age group is determined by the age of the youngest victim for the number of investigations and number of violations while the age group is determined by the age of each victim for the number of victims with confirmed serious injuries and child fatalities.

² When Age of child is calculated as 14years or more, then the Age Group is > 13. Age group of > 13 year old may be a result of a data error entry as child care operations care for children younger than 14 years old.

³ When Date of birth not entered or entered incorrectly for child, Age Group is "Unknown" .

⁴ Includes only those Investigation Violations that are marked as Non-Compliant and has an admin review status of "Waived" or "Upheld"

⁵ A serious injury is not considered confirmed until the investigation results are sent to the provider. Serious Injury is captured in CLASS application and hence data for this report to calculate the count of victims with serious injury is from CLASS.

⁶ Investigations included in counts when the investigation complete date is within the fiscal year.

⁷ Investigations or victims are included in counts when the investigation notification to provider date is within the fiscal year.

⁸ Methodology used to calculate violation counts changed in FY 2021. Values for FY 2020 have been recalculated using the new methodology.
