#### **Executive Summary**

The 2022-23 General Appropriations Act, Senate Bill 1, 87th Legislature, Regular Session, 2021 (Article II, Health and Human Services Commission, Rider 68), requires the Health and Human Services Commission (HHSC) to submit an annual report on the Alternatives to Abortion (A2A) program.

A2A services – including education, care coordination, material goods, housing, and support through maternity homes – are delivered through contracted service providers and their subcontractors. Services are available to pregnant women, their families, and adoptive parents.

During fiscal year 2022, the A2A program contracted with four entities:

- Austin LifeCare (ALC)
- Human Coalition (HC)
- Longview Wellness Center (LWC)
- Texas Pregnancy Care Network (TPCN)

TPCN subcontracted with entities across the state. ALC provided A2A services from three locations, HC provided services at two locations, and LWC provided services at five locations. Altogether, the four contractors provided services at a total of 179 physical locations, two virtual clinics and 10 mobile units.

In fiscal year 2022, A2A served a total of 113,125 unduplicated clients who received 2,230,713 services and 178,240 referrals to government assistance and social service programs.

#### Introduction

The 2022-23 General Appropriations Act, Senate Bill 1, 87th Legislature, Regular Session, 2021 (Article II, HHSC, Rider 68), requires HHSC to submit a report on the A2A program no later than December 1 of each year to the Governor and the Legislative Budget Board. As required by Rider 68, this report provides:

- The total number of A2A providers, including subcontractors, by geographical region, and the total number of unduplicated clients served by each provider, by gender and age;
- A description of A2A outreach efforts by providers and HHSC;
- Total expenditures, by method of financing;
- Total contract amounts by provider, including subcontractors; and
- Any outcome measures included in contracts with providers.

Additionally, this report includes an overview of two pilot projects implemented by HC and TPCN.

#### **Background**

The A2A program was created by the 2006-07 General Appropriations Act, Senate Bill 1, 79th Legislature, Regular Session, 2005 (Article II, Special Provisions Relating to all Health and Human Services Agencies, Section 50). A2A is a statewide program promoting childbirth and providing support services to pregnant women, their families, and adoptive parents. Services are available for Texas residents who are pregnant and up to three years post-partum. Clients who have suffered a miscarriage or loss of a child are eligible for services up to 90 calendar days after the miscarriage or loss. Adoptive parents are eligible for up to two years post-adoption finalization, regardless of the age of the child at adoption. The parent, legal guardian, or adult caregiver¹ of a minor (under the age of 18) who is a program client is also eligible for services.

#### A2A is designed to:

- Reduce abortions and improve pregnancy outcomes by helping women practice sound health-related behaviors and improve prenatal nutrition;
- Improve child health and development by helping parents provide responsible and competent care for their children; and
- Improve families' economic self-sufficiency by helping parents continue their education and secure employment.

The A2A program accomplishes its mission by providing the following support services:

- Counseling, mentoring, educational information, and classes on: pregnancy, parenting, adoption, life skills, and employment readiness;
- Material assistance such as car seats, clothing, diapers, and formula;
- Care coordination through referrals to government assistance programs and other social service programs;
- Call center for information or to schedule appointments; and
- Housing and support services through maternity homes.

A2A services are delivered through contracted service providers including pregnancy centers, social service providers, adoption agencies, and maternity homes for pregnant women. Program services are available in person, by phone, or online. In addition to contracting with service providers, HHSC monitors contracted providers' adherence to state rules and policies, provides technical assistance, and collects and maintains program data. Refer to Appendix B for a breakdown of services provided and Appendix C for the 11 statewide HHSC service regions.

The 87th Legislature appropriated \$100,022,732.00 for A2A for fiscal years 2022-2023. HHSC awarded a total of \$47,359,407.06 to four contractors in fiscal year 2022: ALC, HC, LWC and TPCN.

The total contract values for fiscal year 2022 are reflected in Table 1.

HHSC reserved \$185,395.02 to support and administer the A2A program in fiscal year 2022.

#### **Number of Providers and Clients**

During fiscal year 2022, HHSC provided A2A services through four contracted service providers – TPCN, HC, ALC, and LWC – across all 11 HHSC service regions in Texas (see Appendix C).

TPCN used a statewide network of 80 subcontractors with a total of 169 physical locations and 10 mobile units throughout Texas. ALC had three physical locations and a virtual care center, using tele-counseling and online delivery of educational materials and classes. HC delivered services directly through a virtual clinic, in addition to two clinics in Grapevine and Fort Worth. HC provided non-medical goods and services to clients through its onsite clinics and by shipping to its virtual clinic clients. LWC delivered services from five locations in East Texas, including Longview, Kilgore, Gilmer, Mount Pleasant, and Tyler.

All four A2A service providers offered counseling, mentoring, educational information, classes, material goods, care coordination, and support services. For a list of providers and subcontractors by geographic region, see Appendix D.

As shown in greater detail in Table 2, the A2A program provided services to 113,125 unduplicated clients in fiscal year 2022. Of the total clients served, approximately 86 percent were female, with the greatest percentage of clients being between the ages of 23 and 29.

#### **Outreach Efforts**

Outreach remained a priority for service providers and subcontractors in fiscal year 2022. Contracted A2A service providers increased outreach efforts to bolster awareness of the program by reaching eligible clients in need of services. These efforts included:

- Promotion and awareness events;
- Virtual care center launch;
- Online advertising campaigns and A2A-specific websites; and
- Distribution of printed materials such as pamphlets, brochures, and postcards.

ALC used digital advertising, targeting the Austin and Houston metro areas to boost the number of engagements women have with clinics in the network. Additionally, ALC launched an A2A-dedicated website to promote awareness and reach those needing services across the state. In fiscal year 2022, ALC launched its virtual care center. The virtual care center currently provides all four core A2A services. ALC identified over 50 potential community partner candidates to which the virtual care center can refer virtual clients for in-person care. To promote outreach of the clinic, ALC used an internet streaming service and search engine marketing, streaming audio and podcast, custom landing pages, and targeted display ads. From these marketing and outreach strategies, ALC's website received 1,736,922 views and 60,300 website visits, of which 15,295 were driven by the online ads. Additionally, 1,298 potential clients interacted with the website which resulted in 317 calls to ALC inquiring about services.

HC collaborated with the Texas Department of Family and Protective Services staff on curriculum for child abuse prevention and reporting. HC's Community Outreach Coordinators continued to maintain relationships with faith-based organizations and churches, building a strong volunteer network to support its mission; the Community Outreach Coordinators also continue to maintain key relationships with other multi-state partners. Additionally, HC held an adoption training in partnership with Lifeline Children and Family Services, Inc.

LWC partnered with local agencies to promote A2A services at events such as Prematurity Awareness Month activities, Healthy Me Healthy Babies Coalition Prematurity Walk, E-Heart and Strengthening Families Christmas event, and National Folic Acid Awareness Week. Additionally, LWC partnered with the Nurse Family Partnership to disseminate informational packets to the local hospital neonatal intensive care units. LWC provided individual face-to-face presentations, distributed program brochures and pamphlets to potential clients, and reached 1,200 adults in July 2022.

TPCN used its network of subcontractors to maintain and promote awareness in communities served. In addition to outreach efforts by the local subcontractors, TPCN held an annual conference for subcontractors that included training from experts in the delivery of client services, continuing education units for licensed counselors in attendance, and an opportunity for subcontractors to network with others who provide services in the program and exchange best practices. TPCN conducted informational meetings for potential providers across north and south Texas regions throughout the year. TPCN brought on three new subcontractors in fiscal year 2022. Additionally, a current TPCN subcontractor opened a brick-and-mortar A2A support facility in Del Rio.

HHSC continued to provide outreach efforts to its A2A contractors through collaboration with other state programs that serve women and families. The programs with the highest referral and enrollment rates are the Special Supplemental Nutrition Program for Women, Infants and Children (WIC); Medicaid; Supplemental Nutrition Assistance Program (SNAP); and Nurse Family Partnership (NFP). Connecting women and families with program information and access to services remains a priority for HHSC and a requirement of contracted A2A service providers.

#### **Funding and Expenditures**

In fiscal years 2020 and 2021, A2A received federal Temporary Assistance for Needy Families (TANF) block grant and state general revenue funds to support services for pregnant women, their families, and adoptive parents. Though A2A did not receive TANF funding for the 2022-23 biennium, the program did receive an increase in general revenue funds to support continued services and specialized pilot projects. While A2A funding remained level for fiscal years 2006 through 2009, it has increased since fiscal year 2010 (see Table 3).

HHSC awarded a total of \$47,359,407.06, including contract amendments, for the provision of A2A services and specialized pilot projects in fiscal year 2022. Additionally, HHSC reserved \$185,395.02 for the fiscal year to support and administer the A2A program.

#### **Outcome Measures for A2A Providers**

In fiscal year 2022, the A2A program provided 2,230,713 services and 178,240 referrals to government assistance and social service programs to 113,125 unduplicated clients across Texas.

In fiscal year 2022, the A2A program had two outcome measures for service providers:

- At least 20 percent of A2A clients referred to NFP successfully enroll in the program.
- At least 20 percent of A2A clients referred to Medicaid successfully enroll in the program.

NFP is a free program where specially trained nurses regularly visit first-time mothers-to-be starting early in the pregnancy and continuing through the child's second birthday. Expectant mothers benefit by receiving the care and support they need to have a healthy pregnancy. The A2A program referred 14,801 clients (13.1 percent of total clients) to NFP. Due to nurse availability in the NFP program, enrollment may be lower in certain areas, even if referrals increase.

Medicaid provides medical coverage in the state through managed care health plans contracted with HHSC. It ensures pregnant women and their children receive timely and adequate care during and after their pregnancies.

The A2A program continues to partner closely with contractors to assist clients in enrolling in these programs and others for which they may qualify. Successfully enrolled clients are shown below in the enrollment percentages in Table 5.

#### **Pilot Projects**

#### **Background**

HHSC included the option for contractors to submit pilot project proposals at a later date, as determined by HHSC, in its request for applications (RFA)<sup>2</sup> released in March 2020. The intent of the pilot project funding is to allow for a broader array of services and targeted initiatives. Pilot project awardees must have already been a contract recipient. The maximum allowable award for A2A pilot projects was \$2 million. The options for potential pilot projects included, but were not limited to fatherhood initiatives, youth initiatives, continuum of care for pregnant women, or any other proposal that aligns with the A2A overall mission and goals. Pilot projects could include services that are not currently allowable through core A2A services but are consistent with core A2A services.

All proposals submitted were required to include a summary, project description, project timeline, anticipated outcomes, performance measures, and a budget proposal. Proposals were originally intended to be received no later than August 31, 2020, however, this was delayed until December 2021 due to the impacts of the COVID-19 pandemic and an increased demand for core A2A services in fiscal year 2021. Three proposals were received by HHSC in December 2021 and were reviewed using the evaluation scoring criteria outlined in the RFA.

With the significant investment in the A2A program from the 87th Texas Legislature for the 2022-23 biennium, HHSC was able to fund two of the three proposed pilot projects. Pilot projects were initiated in fiscal year 2022 and will be funded through fiscal year 2023 with the option for renewal. The purpose is to enhance existing services or assess the need for a broader array of services that are consistent with the mission and goals of the A2A program. TPCN was awarded \$2 million for the 2022-23 biennium for the Modern Adoption Plan and HC was awarded more than \$1 million for Maternal Health Disparities, as described below.

#### **Project Description: Modern Adoption Plan**

TPCN's Modern Adoption pilot project is a media campaign to change perceptions regarding adoptions in Texas. Modern Adoption's mission is to raise the profile of adoption and present it as an equally viable and acceptable alternative for

unwanted pregnancy, with the intent of reducing the number of abortions in Texas. The specific goal of the project is to change the perception of adoption among women and girls ages 12-34.

The media campaign targets audiences in the seven Texas counties with the greatest number of abortions: Bexar, Collin, Dallas, Denton, Harris, Tarrant, and Travis. TPCN will target key elements based on current trends, data, and available media solutions best suited to reach the target audience's media consumption habits.

#### **Project Description: Maternal Health Disparities**

HC's pilot project is designed to identify strategies, tools, and services that the A2A program and HC providers can use to improve statewide maternal and infant health outcomes and reduce health disparities. The pilot project aims to identify high-risk mothers early in their pregnancies to ensure they receive a timely start to prenatal care, address identifiable risks, and receive personalized support for their pregnancy health. The project includes the development of tools that will enable HC providers to better reach and identify mothers at high risk of poor outcomes, deploy services tailored to improving maternal and infant health, and offer clear metrics that align program activities with program goals. The results of this project will allow HHSC to demonstrate impact on maternal health disparities.

#### Conclusion

In fiscal year 2022, the A2A program delivered services across Texas to 113,125 unduplicated clients. The implementation of two new A2A pilot projects, the Modern Adoption Plan and Maternal Health Disparities, has allowed for a broader array of services and targeted initiatives. Funding for A2A continues to meet the needs of clients and further the goals of A2A by reducing abortions, improving pregnancy outcomes, improving child health and development, and improving families' economic self-sufficiency.


