Executive Summary

The 2022-23 General Appropriations Act, Senate Bill (S.B.) 1, 87th Legislature, Regular Session, 2021 (Article II, Health and Human Services Commission, Rider 68), requires the Health and Human Services Commission (HHSC) to submit an annual report on the Alternatives to Abortion (A2A) program.

A2A services – including education, care coordination, material services, housing, and support through maternity homes – are delivered through contracted service providers and their subcontractors. Services are available to pregnant women, their families, and adoptive parents.

During fiscal year 2023, the A2A program contracted with four service providers:

- Austin LifeCare (ALC)
- Human Coalition (HC)
- Longview Wellness Center (LWC)
- Texas Pregnancy Care Network (TPCN)

TPCN subcontracted with 83 service providers across the state. ALC provided A2A services from three locations, HC provided services at two locations, and LWC provided services at five locations. Altogether, the four contractors provided services at a total of 190 physical locations, two virtual clinics, and 12 mobile units.

In fiscal year 2023, A2A served a total of 125,416 unduplicated clients who received 2,215,152 services and 203,123 referrals to government assistance and social service programs. All funds awarded for client services were expended in fiscal year 2023.

Future Program Changes

Senate Bill (S.B.) 24, 88th Legislature, Regular Session, 2023¹ established the Thriving Texas Families (TTF) program as a continuation of the A2A program. The purpose of TTF is to facilitate the operation of a statewide support network that provides community outreach, consultation, and care coordination for women with an unexpected pregnancy. Additionally, S.B. 24 defines and expands TTF client

eligibility and program services and establishes performance outcomes for the program. These changes are being incorporated in the program during the 2024-25 biennium.

To help inform the implementation of TTF and S.B. 24 requirements, HHSC released a Request for Applications (RFA) on November 8, 2023², to solicit innovative TTF pilot projects. The pilot projects will use research-based strategies to deliver TTF services and demonstrate program outcomes. Additionally, TTF will conduct an impact evaluation in fiscal year 2025 which will measure the effects of services on participants receiving services through the program and report on measured performance outcomes. Results from the pilot projects and the impact evaluation, as well as input from current TTF contractors, will help inform future initiatives for the TTF program and will be included in future legislative reports.

This report reflects program requirements in fiscal year 2023, prior to the enactment of S.B. 24.

Introduction

The 2022-23 General Appropriations Act, S.B. 1, 87th Legislature, Regular Session, 2021 (Article II, HHSC, Rider 68), requires HHSC to submit a report on the A2A program no later than December 1 of each year to the Governor and the Legislative Budget Board. As required by Rider 68, this report provides:

- The total number of A2A providers, including subcontractors, by geographical region, and the total number of unduplicated clients served by each provider, by gender and age;
- A description of A2A outreach efforts by providers and HHSC;
- Total expenditures, by method of financing;
- Total contract amounts by provider, including subcontractors; and
- Any outcome measures included in contracts with providers.

Additionally, this report includes an overview of the accomplishments achieved by the two pilot projects for fiscal year 2023 by HC and TPCN, which began in fiscal year 2022.

Background

The A2A program was created by the 2006-07 General Appropriations Act, S.B. 1, 79th Legislature, Regular Session, 2005 (Article II, Special Provisions Relating to all Health and Human Services Agencies, Section 50). A2A is a statewide program promoting childbirth and providing support services to pregnant women, their families, and adoptive parents. Services are available for Texas residents who are pregnant and up to three years post-partum. Clients who have suffered a miscarriage or loss of a child are eligible for services up to 90 calendar days after the miscarriage or loss. Adoptive parents are eligible for up to two years post-adoption finalization, regardless of the age of the child at adoption. The parent, legal guardian, or adult caregiver of a minor (under the age of 18) who is a program client is also eligible for services.

A2A is designed to:

- Reduce abortions and improve pregnancy outcomes by helping women practice sound health-related behaviors and improve prenatal nutrition;
- Improve child health and development by helping parents provide responsible and competent care for their children; and
- Improve families' economic self-sufficiency by helping parents continue their education and secure employment.

The A2A program accomplishes its mission by providing the following support services:

- Counseling, mentoring, educational information, and classes on: pregnancy, parenting, adoption, life skills, and employment readiness;
- Material assistance such as car seats, clothing, diapers, and formula;
- Care coordination through referrals to government assistance programs and other social service programs;
- Call center for information or to schedule appointments; and
- Housing and support services through maternity homes.

A2A services are delivered through contracted service providers including pregnancy centers, social service providers, adoption agencies, and maternity homes for pregnant women. HHSC contracts directly with service providers who

provide client services and with one organization (TPCN) that uses a subcontractor model to deliver services. Program services are available in person, by phone, or virtually. In addition to overseeing the A2A program and services, HHSC also monitors HHSC contracted service providers' adherence to state rules and policies, provides technical assistance, and collects and maintains program data. Refer to Appendix B for a breakdown of services provided and Appendix C for the 11 statewide HHSC service regions.

The 87th Legislature appropriated \$100,022,732 for A2A for the 2022-23 biennium. The 88th Legislature appropriated an additional \$25,000,000 in supplemental funding to be expended in fiscal year 2023 through fiscal year 2025. HHSC awarded a total of \$62,001,580.74 to four contractors in fiscal year 2023: ALC, HC, LWC, and TPCN.

The total contract values for fiscal year 2023 are reflected in Table 1.

HHSC reserved \$170,930 to support and administer the A2A program in fiscal year 2023.

Number of Providers and Clients

During fiscal year 2023, HHSC provided A2A services through four contracted service providers – ALC, HC, LWC and TPCN– that served all 11 HHSC service regions in Texas (see Appendix C).

In fiscal year 2023, TPCN used a statewide network of 83 subcontractors with a total of 180 physical locations and 11 mobile units throughout Texas. ALC provided services through three physical locations, one mobile unit, and a virtual care center, using tele-counseling and online delivery of educational materials and classes. HC delivered services directly through a virtual clinic, in addition to two clinics in Grapevine and Fort Worth. HC provided non-medical goods and services to clients through its onsite clinics and by shipping to its virtual clinic clients. LWC delivered services from five locations in East Texas, including Longview, Kilgore, Gilmer, Mount Pleasant, and Tyler.

All four A2A service providers offered counseling, mentoring, educational information, classes, material assistance, care coordination, and support services. For a list of providers and subcontractors by geographic region, see Appendix D.

As shown in greater detail in Table 2, the A2A program provided services to 125,416 unduplicated clients in fiscal year 2023. Of the total clients served, approximately 86 percent were female, with the greatest percentage of clients being between the ages of 23 and 29.

Outreach Efforts

Outreach remained a priority for service providers and subcontractors in fiscal year 2023. Contracted A2A service providers increased outreach efforts to bolster program awareness by reaching eligible clients in need of services. These efforts included:

- Promotion and awareness events with local community partners;
- Mobile clinic drives;
- Advertising campaigns and A2A-specific websites; and
- Distribution of printed materials, such as pamphlets, brochures, and postcards.

Austin LifeCare

ALC significantly enhanced its outreach efforts in fiscal year 2023 by leveraging community partnerships. ALC is a level 2 HHSC Community Partner Program (CPP), which allows them to assist A2A clients with their YourTexasBenefits application. Additionally, ALC worked closely with HHSC CPP to support care coordination staff by designating them as CPP site navigators. Each of its clinic directors also participates as a CPP site manager for ALC clinics.

ALC's Spring Branch clinic used its community centers to promote healthy families and maternal health by hosting an outreach event to reach adults and children and provide material assistance. ALC's Austin clinic and mobile unit hosted an outreach event at a local church to share information about A2A services. ALC's mobile unit continued its outreach efforts at apartment complexes around Austin. An additional outreach event was hosted at a low-income apartment complex to share information about A2A services, distribute care packages, and provide diapers to clients. Overall, 37 participants became active A2A clients, 21 contacts were made, and 32 contacts received material assistance from the mobile unit outreach events. Lastly, ALC's Austin clinic hosted a diaper drive where over 11,000 diapers were distributed during the event.

Human Coalition

HC held several outreach activities throughout fiscal year 2023. HC partnered with local community partners, diaper banks, and food banks to serve pregnant women and families with small children across Texas. In December 2022, HC conducted a compliance training for staff and a provider training on human trafficking. In addition, HC hosted webinars as an outreach effort to inform communities and agencies about A2A services. HC outreached to maternity homes, adoption agencies, community partners, food and diaper banks, training and education centers, libraries, extension agencies, housing programs, and other community agencies across Texas to invite them to attend informational webinars held throughout the year on A2A services. In total, HC invited 2,388 community partner organizations to attend.

Longview Wellness Center

LWC prioritized critical outreach services in fiscal year 2023 to reach targeted populations and share educational information. To reach underserved non-English speaking populations in the East Texas region, LWC integrated promotional and educational materials to support non-English speaking individuals and hired a bilingual community coordinator during the first quarter. Due to the significant number of underserved and non-English speaking families in need of services in the community, LWC restructured its enrollment processes, activities, and schedules for assisting with non-medical basic needs for eligible clients.

LWC's outreach focused on promotion of services, client recruitment, and establishing partnerships for supportive referral resources. Community outreach and promotional activities were held throughout the year at partnering organizations such as local Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) offices, city parks and recreation centers, local city community engagement events, family coalition events, local school resource centers, Head Starts, and school districts.

Staff continued promoting A2A awareness and focused on identifying barriers that impede access to care. Staff strategically mapped out targeted areas to partner with laundromats near city bus routes for families or individuals that lack transportation and reached out to the City of Longview to partner on a discounted rate for bus passes to support A2A families with transportation needs. They also coordinated and hosted a donation drive for laundry essentials such as detergent and softeners for clients.

The Longview Wellness Center started an initiative with Marshall Independent School District regarding the need for A2A services for teen pregnancies. They supplied information packets on how to access services and gave presentations to Marshall Independent School District's Health Advisory Council and health education classes. Staff continue to collaborate with school staff to engage students. LWC's Social Services Resource Directory was also updated to serve as a resource for LWC staff and community partners to link individuals to services, including A2A services.

LWC staff also recognized Black Maternal Mental Health Week, which occurred July 19, 2023, through July 25, 2023, by disseminating information to individuals to spread awareness about the importance of moms and families recognizing warning signs of health issues and improving maternal health.

Texas Pregnancy Care Network

TPCN continued its outreach focus on provider recruitment and educational events. Throughout the year, TPCN expanded its network of new providers by adding two locations for a total of 83 subcontractors with 180 physical locations and 11 mobile units.

TPCN hosted educational events at the Texas School Nurses Organization Conference, in which 364 professionals were informed about the A2A program. TPCN conducted informational meetings for potential providers in the South, East, Southeast, and West Texas regions and continued discussions with other potential providers about becoming a TPCN subcontractor.

Health and Human Services Commission

HHSC continues to provide outreach efforts to its A2A contractors through collaboration with other state programs that serve women and families. Connecting women and families with program information and access to services remains a priority for HHSC and a requirement of contracted A2A service providers.

Funding and Expenditures

The 2022-23 General Appropriations Act, S.B. 1, 87th Legislature, Regular Session, 2021 (Article II, HHSC, Rider 68), appropriated \$100,022,732 for the biennium for the A2A program to support continued services. In fiscal year 2023, the A2A program was appropriated \$25,000,000 in supplemental funding through S.B. 30, 88th Legislature, Regular Session, 2023 (Article III, Health and Human Services, Section 3.09). Details on the supplemental funds are provided below. While A2A funding remained level for fiscal years 2006 through 2009, it has increased since fiscal year 2010 (see Table 3).

Supplemental funds appropriated through S.B. 30 are included in the 2022-23 general revenue total in Table 3 above.

In fiscal year 2023, HHSC awarded a total of \$62,001,580.74, for the provision of A2A services and specialized pilot projects. The pilot projects include a project to address Maternal Health Disparities, which supports pregnant women who are or are at risk of experiencing a high-risk pregnancy, and a project on Modern Adoption, which uses a media strategy to inform, educate, and increase awareness of adoption. Additionally, HHSC reserved \$170,930 for fiscal year 2023 to administer the A2A program.

Table 4 includes all fiscal year 2023 contract award amounts, including supplemental funds that were awarded late in fiscal year 2023. Information on supplemental funding can be found in the section below. For total allocated contract amounts by service provider, including subcontractors, see Appendix D. All funds awarded for client services were expended in fiscal year 2023.

Fiscal Year 2023 Supplemental Funding

S.B. 30, 88th Legislature, Regular Session, 2023 (Article III, Health and Human Services, Section 3.09), appropriated the A2A program \$25,000,000 from the general revenue fund for fiscal year 2023. The appropriation became effective June 9, 2023. All funding allocated to A2A through S.B. 30 must be expended no later than June 9, 2025.

A2A program contractors were given the opportunity to accept supplemental funds appropriated to address the immediate need for increased services for A2A clients. TPCN and LWC accepted a combined total of \$10,559,031.49 of supplemental funds for the remainder of fiscal year 2023 to address immediate client service needs. All supplemental funds awarded in fiscal year 2023 were expended. Additionally, remaining supplemental funds (\$14,440,968.51) not awarded in fiscal year 2023 will be awarded to contractors for fiscal years 2024 and 2025 and will be expended no later than June 9, 2025. Table 5 below provides an overview of supplemental funds awarded to each contractor in fiscal year 2023.

Outcome Measures for A2A Providers

In fiscal year 2023, the A2A program provided 2,215,152 services and 203,123 referrals for government assistance and social service programs to 125,416 unduplicated clients across Texas. Of the 125,416 clients, 118,436 were duplicated continuing clients. This number reflects clients who received services for more than one month in the fiscal year. Duplicated continuing clients are counted in each month that they received services. Due to an increased need for A2A services in fiscal year 2023, the A2A program saw a greater number of clients who returned for ongoing services. Table 6 below provides an overview of the number of unduplicated and continuing duplicated clients served by contracted service providers.

In fiscal year 2023, the A2A program also had two outcome measures for service providers:

- At least 20 percent of A2A clients referred to Nurse Family Partnership (NFP) successfully enroll in the program.
- At least 20 percent of A2A clients referred to Medicaid successfully enroll in the program.

NFP provides services at no cost to the participant. Specially trained nurses regularly visit first-time mothers-to-be starting early in the pregnancy and continue through the child's second birthday. Expectant mothers benefit by receiving the care and support they need to have a healthy pregnancy. Due to nurse availability in the NFP program, enrollment may be lower in certain areas, even if referrals increase. In fiscal year 2023, the A2A program referred 6,441 clients to NFP, which represents over 5 percent of total clients. Not all clients referred to the program

were able to enroll due to varying reasons including, but not limited to, limited NFP nurse availability, ineligibility, and other factors.

Medicaid provides medical coverage in the state through managed care health plans contracted with HHSC. It ensures pregnant women, and their children receive timely and adequate care during and after their pregnancies.

The A2A program continues to partner closely with contractors to assist clients in enrolling in these programs and others for which they may qualify. Successfully enrolled clients are shown below in the enrollment percentages in Table 7.

Pilot Projects

Background

With investment from the 86th Legislature, the A2A program funded two pilot projects through a Request for Application process. Pilot projects began in fiscal year 2022 and are funded through fiscal year 2025. The purpose of the pilot projects is to enhance existing services or assess the need for a broader array of services that are consistent with the mission and goals of the A2A program. HHSC awarded TPCN \$2 million for the 2022-23 biennium for the Modern Adoption project, and \$1,039,875.50 to HC for a Maternal Health Disparities project. Each awardee's descriptions, highlights, and key successes are below.

Project Highlights and Descriptions

Modern Adoption Plan

TPCN's Modern Adoption pilot project is a media campaign focused on changing perceptions around adoptions in Texas. Modern Adoption's mission is to raise the profile of adoption and present it as an equally viable and acceptable alternative to abortion. The target audience for this media campaign are women and girls ages 12 to 34 years. The campaign launched in August 2022 in seven Texas counties where 85 percent of abortions in the state occur, including Bexar, Collin, Dallas, Denton, Harris, Tarrant, and Travis. Through the Modern Adoption campaign, TPCN targeted key elements based on current trends, data, and available media solutions best suited to reach the target audience's media consumption habits.

Fiscal year 2023 began the second year of the pilot project initiatives for TPCN. Based on data received from a fiscal year 2022 survey of 400 respondents, in 2023 TPCN conducted another ad effectiveness study with 461 respondents. The 2023 results found that after seeing the ad, 78 percent of those ages 16 to 20 years indicated being somewhat or much more likely to consider investigating adoption options if the situation ever arose.

The Modern Adoption pilot project aims to change perceptions using digital ads, streaming audio, and driving traffic to the Modern Adoption Plan website (www.modernadoptionplans.org), which hosts information about the adoption process. By the end of fiscal year 2023, TPCN had 149,703,572 campaign

impressions, exceeding their planned impressions by over 13 million. TPCN included an additional campaign, Embrace Podcast Network spots, which succeeded in its goal of 3 million impressions by reaching 3,302,181 total impressions. TPCN worked with Google Ad placement to drive traffic to the Modern Adoption Plan website and leverage Embrace Podcast Network spots.

Maternal Health Disparities

The HC Maternal Health Disparities Pilot Project is designed to identify strategies, tools, and services that the A2A program and HC providers can use to improve statewide maternal and infant health outcomes and reduce health disparities, with a focus on identifying high-risk mothers early in their pregnancies to ensure they receive a timely start to prenatal care; addressing identifiable risks; and providing personalized support for their pregnancy health. Many of the women entering the program were single and were in their first or second trimester.

HC launched a nutritional program that allowed clients to receive a nutritional benefit based on the needs discussed during an appointment with a nutritionist. HC is also exploring a new virtual nutrition educational program to use as a resource for those who opt out of nutritional services.

Currently, HC is using a questionnaire to capture patient feedback from those who drop out of the program. HC reviews these survey results to determine the number of participants who continue participating in the program, as well as reasons why patients withdraw from the program. There is also a post-survey for patients who complete the program. The survey provided significant feedback to the Maternal Health Disparities pilot. Of the clients completing the program, 100 percent indicated they would recommend this program to other expectant mothers or postpartum mothers needing support. Respondents could name the specific factors they identified as improvements in their health or well-being. These ranged from better nutritional practices, improved mental health, and increased confidence.

The original cohort began in June 2022, ending with 33 clients. By the end of fiscal year 2023, there were 29 births, including two sets of twins. Ninety-seven percent of these high-risk births resulted in planned positive outcomes, including normal birth weights, no pre-term deliveries, and no neonatal intensive care unit admissions. In June 2023, the second cohort began with 13 enrolled high-risk clients and by August 2023, 34 clients were enrolled.

Conclusion

In fiscal year 2023, the A2A program delivered services across Texas to 125,416 unduplicated clients. The continuation of two A2A pilot projects, Modern Adoption and Maternal Health Disparities, has allowed for a broader array of services and targeted initiatives. Funding for A2A continues to meet the needs of clients and further the goals of A2A by reducing abortions, improving pregnancy outcomes, improving child health and development, and improving families' economic self-sufficiency.

During the 2024-25 biennium, HHSC will be incorporating changes made through S.B. 24, which established the TTF program as a continuation of the A2A program.


