<sup>5</sup> A serious injury is not considered confirmed until the investigation results are sent to the provider. Serious Injury is captured in CLASS application and hence data for this report to calculate the count of victims with serious injury is from CLASS.

Note - For an investigation with multiple confirmed victims but only 1 victim with a serious injury the count of victims with confirmed serious injury will be 1.
