¹Age Group is determined by the age of the youngest victim (with serious injury, if applicable) for the Number of Investigations and Number of Violations rows, while Age Group is determined by the age of each victim for the Number of Victims w/ Confirmed Serious Injury rows.

² When Age Group is calculated as 14 years or more, then the Age Group is "> 13 years". These counts may be the result of a data entry error, since child care operations care for children younger than 14 years old.

³When the date of birth is not entered or entered incorrectly for a child, Age Group is "Unknown".

⁴ Includes only those Investigation Violations that are marked as Non-Compliant and have an Admin Review status of either "Waived" or "Upheld".

⁵ A serious injury is not considered confirmed until the investigation results are sent to the provider. Serious Injury is captured in the CLASS application and, therefore, data for this report to calculate the count of victims with serious injury is from CLASS. Note - If there is an investigation with multiple confirmed victims, but only 1 victim had a serious injury then the count of victims with confirmed serious injury will be 1.

⁶ Investigations included in counts when the investigation completion date is within the fiscal year.

⁷ Investigations or victims are included in counts when the investigation notification to provider date is within the fiscal year.
