## Executive Summary

The *Coronavirus Disease (COVID-19) Funding to Nursing Facilities and Hospitals* report is submitted pursuant to 2024-25 General Appropriations Act, House Bill (H.B.) 1, 88th Legislature, Regular Session, 2023 (Article II, Health and Human Services Commission [HHSC], Rider 150).

Rider 150 requires HHSC to "...develop a report detailing the total value and uses of COVID-19-related Federal Funds, including Provider Relief Funds, provided directly to nursing facilities and hospitals contracting with HHSC since the beginning of the public health emergency. The report should include any temporary rate increases provided to nursing facilities related to the COVID-19 pandemic. Any facilities that do not provide information requested by the commission necessary to complete the report shall be identified in the report."

The report shall be submitted to the Office of the Governor, Legislative Budget Board, and any appropriate standing committee in the Legislature on December 1 and June 1 of each fiscal year of the 2024-25 biennium.

Rider 150 extends the provisions of the 2022-23 General Appropriations Act, Senate Bill (S.B.) 1, 87th Legislature, Regular Session, 2021 (Article II, HHSC, Rider 143). As such, the Rider 150 reports are a continuation of HHSC's previously published series of reports required by Rider 143.

This report is the second report in a series of four reports to be developed by HHSC for Rider 150. This report includes data reported by nursing facilities (NFs) and hospitals from January 31, 2020, through January 31, 2024; data collected prior to September 1, 2023, was originally collected for Rider 143.

# 1. Introduction

The federally-declared COVID-19 public health emergency (PHE) began in January 2020 and expired on May 11, 2023. During the COVID-19 PHE, NFs and hospitals received federal funds to assist with additional costs and lost revenue that occurred as a result of this PHE.

In typical circumstances, federal funds might flow through or be identified during the traditional state budget process. In contrast, these COVID-19 federal funds were distributed directly to providers. Therefore, the state did not act as the facilitator or distributor of most of the federal funds available to Texas healthcare institutions during this PHE. Rider 150 (previously Rider 143) enables HHSC to collect and report on the types and amounts of federal funds that flowed to NFs and hospitals during the COVID-19 PHE.

## Previous Legislation

Rider 150 extends the provisions of the 2022-23 General Appropriations Act, S.B. 1, 87th Legislature, Regular Session, 2021 (Article II, HHSC, Rider 143), which had previously required that NFs and hospitals report on their sources of COVID-19 federal funding. In accordance with Rider 143 requirements, HHSC collected data from NFs and hospitals spanning from the beginning of the PHE until the expiration of Rider 143 on September 1, 2023.

Separately, in accordance with S.B. 809, 87th Legislature, Regular Session, 2021, NFs and hospitals (among other healthcare institutions) were also required to submit COVID-19 federal funds reports on a monthly basis. The provisions of S.B. 809 expired on September 1, 2023, and were not extended. Although NFs and hospitals still need to submit reports after September 1, 2023, pursuant to Rider 150, the reports no longer need to be submitted to HHSC on a monthly basis and are instead submitted once every six months. This change in reporting frequency addressed a challenge previously reported by providers.

## 2. Federal Funds Data

There are over 600 hospitals and over 1,100 NFs that are subject to the reporting requirements of Rider 150. The exact number of facilities required to report changes over time due to the dynamic nature of provider disenrollment and licensure changes.

This report includes the monthly data collected under Rider 143 (January 31, 2020, through August 31, 2023), plus six months of data collected under Rider 150 (September 1, 2023, through January 31, 2024). The data collected for Rider 150 totals \$0 because the COVID-19 PHE expired prior to the beginning of the first Rider 150 reporting period. COVID-19 federal funds payments to healthcare providers ended in June 2023 – shortly after the PHE ended on May 11, 2023.<sup>1</sup>

### Data Limitations

The financial data included in this report is limited, incomplete, and potentially inaccurate because many providers gave estimates instead of precise data. For the monthly reporting previously required by Rider 143, many providers stated that their financial data was not available upon each monthly deadline. Although the reporting frequency changed after August 31, 2023, this change occurred after federal funds payments had already ended. HHSC observed a higher response rate after the change in reporting for Rider 150, but the data provided thereafter reflected \$0 in federal funding.

As such, HHSC lacks sufficient data to accurately report on the COVID-19 federal funds received by NFs and hospitals. For the three monthly reporting periods between June 2023 through August 2023, for example, an average of approximately 54 percent of NFs and hospitals submitted their reports.

### Reporting Periods

For Rider 150, reports were collected by March 1, 2024, and covers the period from September 1, 2023, through January 31, 2024. This report contains data collected from NFs and hospitals in accordance with previous legislation (S.B. 809 and Rider 143) and thus also contains data from January 31, 2020, through August 31, 2023.

Subsequent semi-annual reports from NFs and hospitals will be due on September 1, 2024 (for the reporting period of February 1, 2024, through July 31, 2024), and March 1, 2025 (for the reporting period of August 1, 2024, through January 31, 2025).

## Data Summaries

COVID-19 federal funds data is summarized in Table 1, and the uses of these funds are summarized in Table 2 and Table 3. This summarized information is broken out into monthly data in Appendix A. Lastly, a list of facilities that did not provide information requested by HHSC necessary to complete the report is contained in Appendix B.

Note that although the financial information in Table 1 through Table 3 represents the aggregate periods of January 31, 2020, through January 31, 2024, \$0 was reported for the periods of September 1, 2023, through January 31, 2024.

### 3. COVID-19 Rate Increases for Nursing Facilities

During the COVID-19 PHE, HHSC adopted temporary COVID-19 rate add-ons for NFs to support access and safety. HHSC also adopted Texas Administrative Code (TAC), Title 1, Section 355.205, regarding Rule for Emergency Temporary Reimbursement Rate Increases and Limitations on Use of Emergency Temporary Funds for Medicaid in Response to Novel Coronavirus (COVID-19). A temporary COVID-19 rate add-on of \$19.63 per diem for each NF Resource Utilization Group was implemented on April 1, 2020, and ended on May 11, 2023, due to the end of the PHE.

NF providers could use the additional funding for COVID-related expenses, including direct care staff salary and wages, PPE, and dietary needs and supplies. Regarding direct care staff salaries and wages, NF providers could use the additional funding only to increase staff compensation through reimbursement of overtime or lump sum bonuses. Approved uses included bonuses for hazard pay or other methodologies that would not result in future reductions in hourly wages when the temporary rate increases are discontinued.

In addition, the temporary emergency rate increases applied to Medicaid hospice-NF per diem rates. The State of Texas pays the Medicaid hospice provider a hospice-NF rate that is no less than 95 percent of the Medicaid NF rate, \$18.65 per day. This rate is for each individual in an NF and includes room and board furnished by the facility (26 TAC Section 266.305(d) Medicaid hospice-NF per diem rates). Under the Medicaid Hospice Provider Manual, Section 6310 – NF Per Diem Rate, the hospice will then pass that amount on to the NF.

An estimated \$1,233,707,223 in all funds (\$408,622,360 in General Revenue) was distributed to NFs from April 1, 2020, through the end of the COVID-19 PHE on May 11, 2023.



## 4. Conclusion

HHSC initially sought to compare the providers' self-reported data to other publicly available sources to assist in a general validation process. One source considered was the United States Health Resources & Services Administration (HRSA). As of November 2023, the information published by HRSA shows that 32,645 Texas providers (including, but not limited to, nursing facilities and hospitals) received a total of \$9,668,321,753 in federal Provider Relief Funds. HHSC cannot compare this publicly available data at a provider level because the data is searchable only by provider name and not by identifiers utilized by HHSC, such as the National Provider Identifier (NPI) or Facility ID.

According to HRSA, with the passage of the Fiscal Responsibility Act of 2023 and the related rescission of program funds, no further payments will be made to providers under the Provider Relief Fund. HHSC will continue to report on COVID-19 federal funds received by nursing facilities and hospitals in accordance with Rider 150.
