# Background

- Health and Human Services
- The Comprehensive Health Homes for Integrated Care (CHIC) Kids Pilot program focuses on using specialized health homes to improve care coordination for children with medically complex conditions.
- The pilot is unique in facilitating innovative and collaborative coordination between providers and a Medicaid managed care organization (MCO).
- Participation is voluntary for MCOs, providers, and eligible members.

### **Pilot Goals**



TEXAS Health and Human Services

- Improve care coordination for children with medically complex conditions
- Improve access to care and outcomes
- Improve member and caregiver satisfaction
- Identify opportunities to reduce administrative burden for MCOs and providers



### **Pilot Projects**

- Pilot projects were co-designed by a STAR Kids MCO and a specialized health home, with some including additional partnering providers.
- Quick Facts:
  - Eleven pilot project plans received
  - ≻Eight MCOs
  - >Nine unique providers
  - >Austin, Corpus Christi, Dallas, Houston, and San Antonio
  - Estimated 1,500 2,000 eligible members
