Crosswalk of Deleted, New, and Amended Rules Administrator's License

Overview of Changes

This document is a crosswalk of the deleted and amended background check rules pertaining to an administrator's license for residential child care operations that are being amended or replaced with new background check rules, which will become effective on January 13, 2019. In addition, this document describes significant changes to the new or amended rule. A crosswalk for all of the other deleted or amended rules in Chapter 745, Subchapter F can be found in *Background Checks, Crosswalk of Deleted, New, and Amended Rules, All Operation Types*.
