# Forms Update

---

- **Form 1725** – Criminal Conviction History & Registry Checks
- **Form 1729** – Applicant Verification for Employees
- **Form 1734** – Service Provider and Employer Certification of Relationship Status for CDS

# Legislative Update

---

- [Senate Bill \(SB\) 1648](#) and [House Bill \(HB\) 2658](#) requires HHSC to:
  - Develop procedure to verify that a Medicaid recipient or parent/guardian is informed about CDS and given the option to choose to receive care under the model.
  - If the individual declines the CDS option, document the declination.
  - Ensure Medicaid managed care organizations (MCOs) implement this procedure.
- A process like the one described is currently in place through CDS Forms [1581](#), [1582](#), [1583](#) and [1584](#).

# What documents does an FMSEA require to start CDS services?

---

- Forms 1581-1584, and 1586 educate the individual as the employer on their rights, responsibilities and resources in the CDS option.
- Forms 1735 and 1736, service agreement and orientation.

# What documents does an FMSA require to start CDS services? (cont.)

- The FMSA brings the following tax forms to the Employer Orientation:
  - IRS Forms
  - SS-4
  - 2678
  - 8821
  - TWC Forms
  - C-42
  - C-1 with instructions
