

Electronic Visit Verification Health and Human Services Learning Portal Guide

The Texas Health and Human Services Commission (HHSC) published the following instructions guide for creating an account on the HHS Learning Portal, including how to locate and enroll in Electronic Visit Verification (EVV) policy training courses.

Step 1: Access the HHS Learning Portal Website

Click on the following link or type it into your browser to access the HHS Learning Portal: <u>https://learningportal.hhs.texas.gov/</u>:

Step 2: Create an Account

Click the Create new account button in the left corner:



Complete all the required fields, which have exclamation point icons, in the **Age and location verification** screen. When all required information is entered, click the **Proceed** button at the bottom of the page:

The HHS Learning Portal will send an email to the email address that was entered to create the new account. Follow the instructions in the email to complete the account registration process.

- If the registration email has not been received, check the Junk Mail or Spam folders.
 - If the email is in the Junk Mail or Spam folders, follow the <u>instructions to</u> <u>add the HHS Learning Portal as a "safe sender"</u> to ensure future emails are received in the main email inbox.

Step 3: Login to Your Account
