# Introduction

The Children with Special Health Care Needs (CSHCN) Services Program submits the Client Services Data Report for fiscal year 2022 in compliance with the 2022-23 General Appropriations Act, Senate Bill 1, 87th Legislature, Regular Session, 2021 ([Article II, Health and Human Services Commission \[HHSC\], Rider 76b](#)).

Rider 76b requires HHSC to submit a report on the CSHCN Services Program caseload and prescription drug data, including related expenditures, for at least the preceding 36 months and forecasted projections for the 36-month period beginning with the first month after the data is due.

# Background

The CSHCN Services Program provides benefits to low-income children under the age of 21 with special health care needs, as well as people of any age with cystic fibrosis. Program services are paid for through nine billing categories, including:

1. **Durable Medical Equipment:** Tangible support services to assist clients with living and community needs, like wheelchairs.
2. **Drugs and Supplies:** Include medications, blood factor replacement products, and nutritional products or associated supplies.
3. **Family Support Services:** Include disability-related support, resources, or other assistance and may be provided to the family of a client with special health care needs.
4. **Home Health:** Includes a medical or paraprofessional aide provided in the client's home.
5. **Other Hospital:** Includes medically necessary services provided in an outpatient hospital setting such as testing and outpatient procedures.
6. **Inpatient Hospital:** Includes medically necessary services provided while a client is admitted to inpatient hospital care.
7. **Physician and Professional Services:** Include care provided by special therapies including medically necessary occupational, physical, and speech therapy, as well as medical specialists.
8. **Insurance Premiums:** Payment of public or private health insurance premiums to maintain or acquire a health benefit plan or other third-party coverage for the client. Payments are reimbursements of private employer plans.
9. **Transportation:** Includes travel to health care visits and transportation for deceased clients.

The CSHCN Services Program is funded with federal Title V Maternal and Child Health Block Grant funding and state general revenue funding. The program is a payor of last resort.

The program maintains a waiting list of clients seeking health care benefits when appropriated funding is insufficient to support the demand for benefits. These clients are pulled from the waiting list when funding becomes available to serve additional clients. Clients transition from the waiting list based on age, urgency of

need, and the date of application. In fiscal year 2022, the program had three waiting list pulls that resulted in 529 clients being removed from the waiting list and becoming eligible for program benefits. The HHSC rules regarding the waiting list can be found in Texas Administrative Code Title 26, Health and Human Services, Part 1, Section 351.16, Procedures to Address Program Budget Alignment.

The program developed a standard process to routinely compare the availability of unexpended funding this fiscal year, by updating its methodology of client utilization and funding projections. The process resulted in more frequent waiting list removals with more clients receiving services. The program also confers routinely with an actuarial services organization, Rudd & Wisdom, Inc., to prepare program projections and assist in monitoring the program budget. These actuarial projections of client services costs are based upon historical expenditures in the CSHCN Services Program using trend analysis and specific program information.

## Required Data

Caseload and expenditure data for the preceding 36 months is included in Tables 1-10. As required by the Legislative Budget Board, Tables 1-10 display the client services by month and then by fiscal year in their respective category. Fiscal year summary displays the cost per person eligible and cost per person served as annual averages and using unduplicated client counts. One client may receive services in more than one category and across more than one month. Tables include actual expenditures as of August 31, 2022. Data in this report is subject to change due to the 95-day claims filing deadline.
