Fiscal Year 2024 Cutoff Date for Year-end Closeout Processing

This letter notifies providers of the following important claims processing cutoff dates. Please review the information detailed in the remainder of this letter.

- Fiscal Year 2022 (Dates of service 9/1/2021 – 8/31/2022)
Miscellaneous Fee-for-Service (FFS) Claims Cutoff:
Noon, Friday, August 09, 2024
- Fiscal Year 2024 (Dates of service 9/1/2023 – 8/23/2024) FFS
Claims Processing Cutoff:
Noon, Friday, August 23, 2024

Important: FFS claims can take up to 24 hours to process after being submitted to Texas Medicaid & Healthcare Partnership (TMHP).

Miscellaneous FFS Claims

September 1, 2024, starts state fiscal year 2025. Miscellaneous claims occur when the service dates are earlier than two prior fiscal years plus the current fiscal year (Dates of service 9/1/2021 – 8/31/2022). Miscellaneous claims for services that are less than eight years old and/or claims that total less than \$50,000 owed to a single legal entity are paid on a first-come, first-served basis using funds appropriated during each legislative session. Miscellaneous claims over \$50,000 and/or for services more than eight years old cannot be paid except as a special line item in the state budget.

Important: The date payments are issued to your account will vary by financial institution.
