1115 Waiver Update

• HHSC <u>posted</u> the Extension Application for the Texas Healthcare Transformation Quality Improvement Program waiver. The extension request reflects the same terms and conditions agreed to and approved by CMS on Jan. 15, 2021. The extension request is for approximately 10 years, which will allow the 1115 waiver authority to run through 2030.

DSRIP Program Update

• The Healthcare Transformation Waiver (HTW) team is providing technical assistance and reviewing NMI reporting for certain providers.

DSRIP Transition Milestone Progress

- The following deliverables were submitted to CMS by 6/30/21:
 - Assessment of Incentives for Alternative Payment Models report
 - o <u>Guidance for MCOs on Quality Improvement Cost Reporting</u>
 - o Assessment of Telemedicine and Telehealth report
 - Options for the RHP Structure Post-DSRIP report
- HHSC is on schedule to submit the next, and final, DSRIP Transition milestone deliverable to CMS by September 30, 2021. The deliverable is a summary of HHSC's analysis of options for new programs that could be implemented in the next 1115 waiver renewal period or other authority. Examples of potential new programs include state-wide initiatives to address social determinants of health (SDOH) and improve regional population health, and other options.

Post-DSRIP Programs

 - State Fiscal Year 2022 CHIRP Pre-Print (.zip)
 - The programs are pending CMS approval and HHSC has received and addressed questions on each program from CMS.
 - In addition to the existing HHSC webpages from the Fiscal Program Coordination department and Provider Finance Department regarding financial aspects of the DPPs, Medicaid and CHIP Services has new <u>webpages</u> to provide information on quality requirements and reporting for each of the new DPPs.
