<sup>a</sup> The City of Beaumont (located within Jefferson County) operated an LPPF within its jurisdiction until 2023; Jefferson County was authorized to operate an LPPF in 2022. The City of Beaumont and Jefferson County did not, at any point, assess concurrent provider taxes. Jefferson County is currently authorized to operate its LPPF under Health and Safety Code Chapter 300. Effective September 1, 2025, Jefferson County is authorized to operate under its own statute, Health and Safety Code Chapter 292D, created by HB 4835 during Texas' 88<sup>th</sup> Regular Legislative Session.
