- 1. Must have a medical need that cannot be met by the Residential Care (RC) provider. Only one unit of Day Activity and Health Services (DAHS) may be authorized, with RC to provide medical services at DAHS that cannot be provided by the RC facility.
- 2. Authorize Title XIX DAHS only regardless of STAR+PLUS enrollment.
- 3. Must be 18 years of age or over to be able to receive both.
- 4. Even if the service is authorized as a managed care organization (MCO) value added service, the Texas Health and Human Services Commission (HHSC) will be authorized or stay in place.
- 5. Consumer Managed Personal Attendant Services (CMPAS) can only be authorized if the attendant is the spouse and excluded from the STAR+PLUS Program.
- 6. Must be 21 years of age or over to be able to receive both.
- 7. Must be 4 years of age or over to be able to receive both.
- 8. Service available regardless of STAR+PLUS acute care enrollment.
- 9. Individual enrolled in the STAR+PLUS Program or STAR Health and not Medicare will receive acute care services only from the MCO.
- 10. Does not have a need for personal care task and denied attendant services through the STAR+PLUS Program or STAR Health.
- 11. Only if receiving the service would not result in duplication of services.
- 12. Not in conservatorship of the Department of Family and Protective Services (DFPS).
- 13. A member enrolled in STAR will be disenrolled from STAR to be able to access hospice services through HHSC.
- 14. Can only receive Personal Care Services if not enrolled in a 1915(c) waiver.
- 15. Must receive Community First Choice through waiver service provider.
- 16. DAHS is available to individuals enrolled in STAR+PLUS and STAR+PLUS HCBS through their MCO, except for individuals enrolled in HCS, Texas Home Living, DBMD or CLASS, or individuals with a Medicaid type not compatible with managed care, may receive DAHS through Title XIX.

Notes:

- (a) In general, the STAR+PLUS Program is a Texas Medicaid capitated managed care program that offers Medicaid acute care and long-term services and support through an MCO to individuals with disabilities or are age 65 or older. STAR+PLUS is the Home and Community Based Services (HCBS) program which offers enhanced long term services and supports as an alternative to residing in a nursing facility.
- (b) STAR is a Texas Medicaid capitated managed care program that delivers acute care services to non-disabled pregnant women and low income families and children.
- (c) STAR Health is a Texas Medicaid capitated managed care program that delivers acute care services to children age 20 and under in the DFPS conservatorship.
- (d) The Program of All-Inclusive Care for the Elderly (PACE) is mutually exclusive with all other services. If an individual is in an MCO and wants to enroll in PACE, the individual must request disenrollment from managed care.
