Formula Approval Process Changes

Effective January 2, 2019, the state formula pager number (512) 499-6814 will be disconnected. To contact state agency staff:

- 1. Use the formula team inbox (<u>FormulaTeam@hhsc.state.tx.us</u>) for questions regarding drop shipment, formula approval, issuance or policy, and cc <u>Sandra.brown2@hhsc.state.tx.us</u>
- 2. The formula team inbox is and will continue to be monitored regularly by state staff during traditional pager service hours. Local agency staff can expect a response within 20 minutes in most cases.
- 3. Direct calls can be used when preferred however, there may be a delayed response if all team members are attending a meeting or if there are multiple requests for assistance at the same time. Direct line phone numbers:

Formula Approval Reminders

1. State agency approval requests

- a. Ensure all needed information regarding the request is uploaded or entered in the notes section, or growth chart.
- b. Provide a <u>local</u> phone number for state agency (SA) use. Auto generated formula approval request emails often list a call center number.
- c. Read and follow SA comments found on the medical prescription request notes page or the medical prescription line item notes. SA comments often provide instructions for how much formula to issue or when to schedule participants for re-assessment.
- 2. Documentation in the notes section of the medical prescription request page shall include:
 - a. Uploaded prescription documents
 - b. Formula history for all non-contract formula requests (exception: metabolic formulas)
 - c. Diet recall, when needed for growth concerns
 - d. Relevant medical history, when related to the requested formula need

Summary of Changes

- 1) Formula name updates: Enfamil Neuropro Enfacare and Puramino Jr
- 2) Texas WIC Formulary wording change to staff instructions section for Enfacare and Neosure in all forms.
 - Due to system constraints, infants unable to eat solids at 6 months need to return to the clinic **at or after** 6 months of age instead of before.
- 3) Prematurity has been defined as <37 weeks' gestation. Requests for formulas outside this definition should be referred to the local RD or state office consideration.
