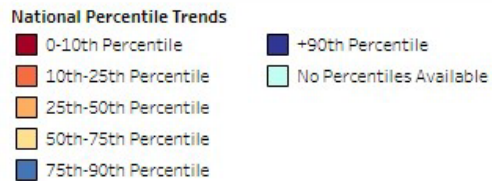

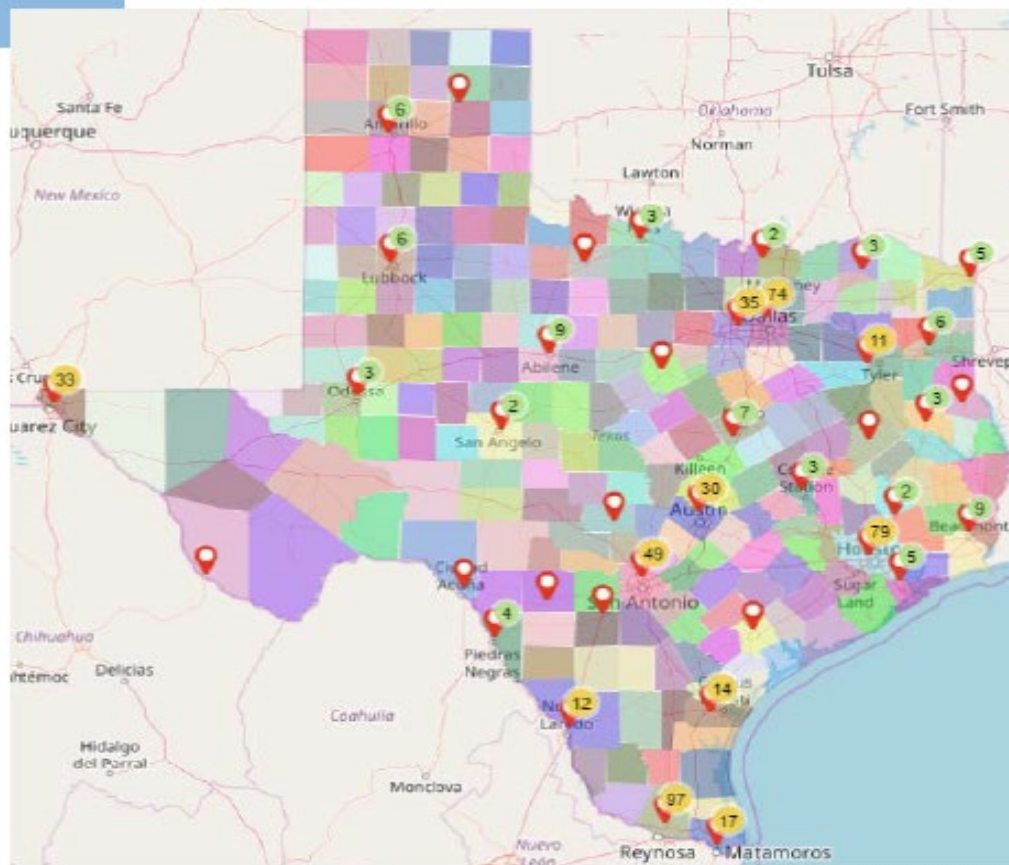
Texas Traditional DMEPOS Medicaid Supplier Location Map

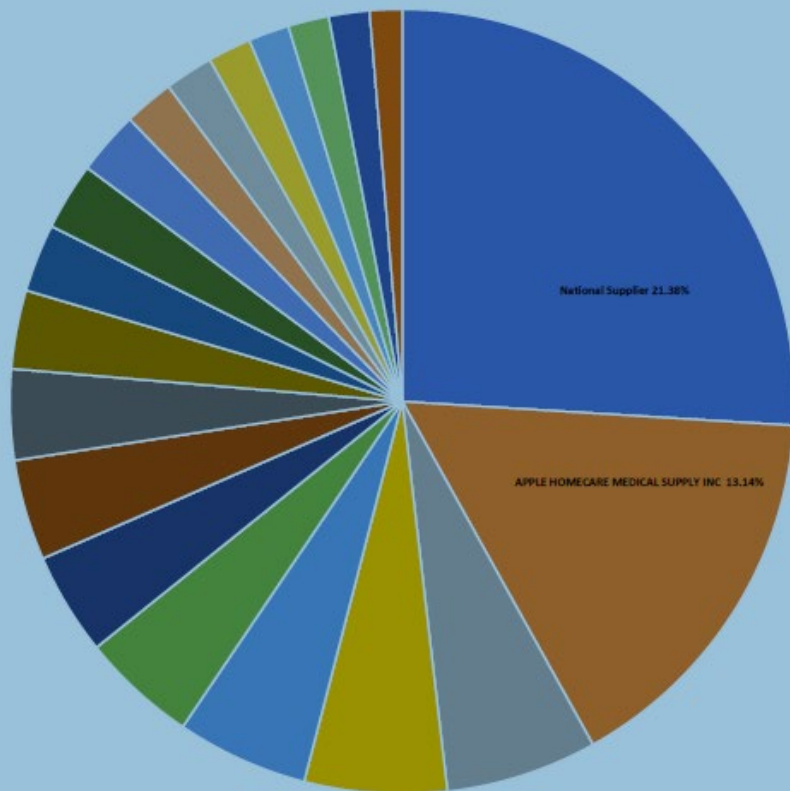

- If authorization has been obtained and the procedure code(s) changes, providers are not required to obtain a modification to the existing authorization.
- We further ask that MCO Plans develop a consistent internal process to facilitate claims payment.
- We ask that prior authorization requirements be given the flexibility and directed guidance from HHSC.
