Temporary Alternative Brand Formulas Available

We have been closely monitoring the availability of certain infant formulas that were impacted by the tornado damage to the Mead Johnson distribution center in Indiana. Mead Johnson has informed us that they anticipate continued impacts to retail availability of Enfamil Gentlease, Enfamil Reguline and Enfamil A.R. through the end of September. On August 26, we received approval from USDA to extend formula flexibilities allowing alternative brands and sizes for Enfamil Gentlease, Enfamil Reguline and Enfamil A.R. through **September 30, 2024**.

If your orders for standard contract formula from Mead Johnson have been allocated or canceled, the alternatives listed below can be ordered instead.

When Gentlease 12.4 oz is not available, WIC customers can:

1. Return to the WIC clinic to have their benefits updated to one of the larger size subcats below, which also includes alternative brand formulas.
2. Select one of the alternative brands listed under subcat 668 below at the store, without needing to return to the WIC clinic.

When Enfamil A.R. 12.9 oz or Enfamil Reguline 12.4 oz is not available, WIC customers can return to the WIC clinic to have their benefits updated to the larger size Enfamil A.R. or Enfamil Reguline.
